Professional Pathway

She moved to Cumbria in 2001 to take up a full-time post in Paediatrics with a mixed caseload; premature babies to 19 years of age with a range of developmental delay, musculoskeletal conditions and neurodisabilities.

Having worked predominantly in the community, becoming a Case Manager was a natural progression, allowing her to use existing knowledge and skills to support clients and their families and enhance clients' long-term recovery, helping them to reach their maximum potential post injury.
