Summary

I have several years of experience of working with clients and families affected by life changing injuries. I started to specialise within the field of acquired brain injury when I worked as a support worker for individuals with acquired brain injury in their homes and in the community whilst studying for my Occupational Therapy Degree. Having qualified as an Occupational Therapist I continued to work in the field of brain injury rehabilitation. My work involves

- Working with children, adults and their families with a goal orientated approach to optimise their recovery and rehabilitation
- Working with clients and their legal representatives who are both pre and post litigation
- Carrying out Immediate Needs Assessments and preparing reports and costs
- Developing and delivering Safeguarding and Mental Capacity Act training for A Chance for Life Ltd clinicians and support teams

Current position

I joined A Chance for Life Ltd in 2012; I work as a Senior Case Manager and Occupational Therapist. In addition to the summary above I have specialist skills and experience in the following

- Carrying out assessments, preparing case management reports and costs.
- Sourcing therapists and coordinating multi-disciplinary teams and rehabilitation programmes.
- Setting and reviewing client-centred goals and programmes, including case management plans and OT goals
- Recruiting, managing and supervising support staff.
- Line managing and supervising Case Managers and Occupational therapists within A Chance for Life
- Working alongside litigation solicitors and financial deputies within the medicolegal field.
- Assessment and rehabilitation of severely cognitively & physically impaired clients
- Vocational rehabilitation and return to work or study
- Working with support teams in complex cases to implement a client centred approach
- Equipment & adaptation assessment & advice
- Setting up and reviewing client-centred goals and programmes, including case management plans
- Making assessments for specialist equipment including seating, wheelchairs and adapted vehicles

- Training support teams in the use of specialist equipment, forming guidelines and completing risk assessments

Key Achievements

- I have worked with several clients to enable a successful return to work or commencing new employment or training. Brain injury education for employers, phased returns, adaptations to the workplace, compensatory strategies, fatigue management and risk assessment have all been key elements I have implemented to support my clients achievements.
- I have worked with a client who lacks insight into his difficulties following brain injury to support him through the family courts to re-establish contact with his young daughter in supervised contact sessions.
- Establishing complex care packages in the community including Support Worker recruitment, training and employment.
- I was involved with the setting up of Cumbria Neurological Alliance in November 2013. The aim of the alliance is to raise awareness and understanding of neurological conditions to ensure that every person diagnosed with a neurological condition has access to high quality, joined up services and information. I have continued my involvement and support of Cumbria neurological alliance and I am a committee member and treasurer for the group.
- I was involved in the development of a joint programme with A Chance for Life Ltd and the Calvert Trust in Keswick. The Supporting Recovery through Outdoor Adventure pilot programme was jointly run by an Occupational Therapist and an outdoor instructor and is designed to develop individual's skills in many areas such as their self-confidence, friendships, cognitive function, motor skills and motivation. This was delivered through outdoor activities and 1:1 and group occupational therapy sessions. I delivered 2 out of the 3 courses which ran.

I have over 20 years experience within the healthcare sector, starting my career as a support worker for people with learning disabilities. I then moved onto supporting people in the community with mental health problems and worked as a Healthcare Assistant at Penrith Hospital.
